\*At all times, the safety of the dogs, handlers, and rats is to be of paramount importance. Rats will be humanely handled and safely confined in aerated tubes or boxes. The rats are also appropriately trained for this sport.

\* By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport.

\* Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.

\* It is expressly understood that participants alone are responsible for the behavior of their dog(s). Any participant whose dog(s) create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the event committee, be asked to leave the event site. In such case, no refund of any fees paid will be made. SuperPup, LLC will assume no responsibilities for any loss, damage, or injury sustained by participants or spectators, or to any of their dogs or property. SuperPup, LLC reserves the right to decline entries for cause and may remove any dog(s) on account of aggression. No one shall have any recourse or claim against SuperPup, LLC or any official thereof.

\* No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

\* Exhibitors are responsible for complete, accurate, and legible information on the entry forms; illegible or incomplete entries cannot be entered in the show.

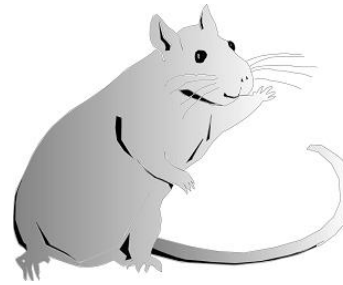

**Limit: Judges are limited to approximately 8 hours of judging - club will limit entries accordingly.**

This trial is indoors on matting. No indoor crating available.

**Late entries** DoS entries are not guaranteed entry and will be accepted only up to judging limits. If planning to enter on DoS, please email your entry info in advance to the Trial Secretary, if possible.

**Schedule: (no formal check-in; just check-in at the gate before class)**

**8:40 am** – First dogs in the blind

## Class order:

Rats in the Garden (outside on leash), Silent Hunt (inside), Rat Trap (outside on leash); then, all classes inside in this order - T1/T2 Ratter (L1), T1/T2 Happy Ratter (L2), T1/T2 Expert (L3), T1/T2 Champion (L4), T1/T2 Extraordinaire/Extreme (L5 and beyond). In case of rain, RIG will become Dump Hunter and all classes will be moved indoors.

**Withdrawals:** Withdrawals after the closing date due to injury of the dog will be eligible for a 75% refund of entry fees paid upon receipt of a note from your veterinarian. The note must be dated and emailed, mailed, or handed to the Trial Secretary **prior to the close of the trial**. Priority mail is not necessary. This refund will be done by check and does not include the service charges paid if your entry was done by PayPal. **Administrative Reminders:** If you provide your email address, we will acknowledge receipt of your entry via email within a few days. If you do not receive an initial confirmation within one week of mailing your entry, contact the Trial Secretary. Any errors must be reported no later than the move-up deadline. If you do not have email but want us to confirm receipt of your entry, please include a SASE with your entry and we will confirm your entry when we email the final confirmation. Please double-check your entry form and remember to sign the Release Form. **A \$50.00 service charge will be added for any returned checks.**

### Exhibitor Information:

- All entries must be accompanied by entry fees and be **postmarked** prior to the day/time of closing to be considered valid.
- Exhibitors not attending the General/Judge's briefings will still be held responsible for knowing the information given in these briefings.
- Any dog that is sick, injured or lame will be excused from the trial grounds.
- Per the rules and SuperPup policy: Prong, choke, and pinch collars can be used on the property but are not allowed in the blind nor on the way to the ring. Electric collars are not allowed to be used on the property during a trial. GPS collars are always welcomed.
- All dogs must be on a maximum 6' leash, except while hunting, and be under control while on the grounds. Flexi-leads may not be used within 100 feet of the buildings. Please attempt to control your barking dogs so that they do not disturb the neighbors. Please do not leave dogs loose in the car with a door or a window open to the point where the dog may escape.
- **At no time should dogs be tied out or otherwise left attached to something other than a human; specifically, leaving your dog(s) tied to an unattended chair or in an open crate is not safe in a trial environment and, therefore, not allowed.**
- No unattended vehicle may be left running while in the field. Doing so presents an unacceptable risk of starting a fire or creating a carbon monoxide issue with dogs in cars parked nearby.
- Please be considerate about picking up after your dogs and leaving the grounds as you found them. Any exhibitor failing to do so may be excused without benefit of a refund if the event committee deems the exhibitor to be in violation of this requirement.
- The schedule is fluid throughout each day. No special considerations will be made to accommodate other activities outside of the trial.
- The blinds are outdoors, with sections covered by tents and shade from trees. The blinds are at least 15' by 15'.
- Handicapped parking must be marked on the entry form. The blinds and rings are not easily wheelchair accessible but it can be done. Please contact the Trial Chairperson in advance so we can ensure a safe path to the rings. Limited up-close handicapped parking is available on a first-come, first-served basis.

**Bitches in season (BIS)** are eligible to compete but will be required to be kept separate from all other dogs and run in panties/britches at the end of their class. Entry fees for BIS that come into season will be refunded until date/time of closing of the trial, if you wish to withdraw. Additionally, if the handler chooses to pull after the closing date, the BIS can be treated as an injured dog and receive a 75% refund after a veterinarian note is received. ***If bringing a BIS, please inform the Trial Secretary prior to the trial and make sure it is announced at the briefing.***

**Loud/Disruptive dogs: Please keep dog barking to a minimum so as not to disturb the neighbors.** Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial, if justification is found to do so by the judge and/or event committee. In that case, no refund of any fees paid will be made. Exhibitors are expected to know the HR rules as far as aggression is concerned, both on and off the course.

*Exercise your dog(s) responsibly. Please pick up after your dog at the show site and hotels. All dogs must be on leash at the trial site except when in the ring hunting.*
