ENTRY FEES

Entries for standard classes (Ratters and Happy Ratters) are \$25. Entry for the game (Box-A-Rat) is \$20. A returned check does not constitute a valid entry and will incur a \$50 fee. No refunds after pre-entry closes.

VOLUNTEERS

We need your help to run the trial smoothly. It is a great way to learn more about the sport and improve your game. No experience required; we will teach you.

PARKING

There is ample parking around the building. We have limited space for RV's (dry camping) for vehicles no longer than 22'. Register RV's through the Trial Secretary. No other overnight parking is permitted.

CRATING

Crating space is available for entered dogs indoors in air conditioning. The event site requires a clean mat be placed on the floor under the crate. Dogs must be created when not running. No x-pens allowed. Empty crates may be left overnight, but IRDTC will not be responsible for any lost or damaged items left at the show site.

COLLARS/LEASHES

While not actively working, dogs must be on a fixed leash 6' or shorter to avoid dog-to-dog contact. Dogs working in the ring naked (without a collar or leash). Dogs must enter and exit the search area on a leash attached to a collar or harness.

A GLIMPSE INTO HAPPY RATTERS

All participants must have fun!!

We will be hunting rats in an "urban setting" with clean and safe garbage (boxes, paper, etc – no hay).

Rats in the ring are enclosed in a container; the dogs can hear and smell them.

All breeds and mixed breeds over six (6) months old can be entered. They must be registered with Happy Ratters and have a registration number (Happyratters.com).

IRDTC By-Laws prevent dogs in season from participating.

Handicapped dogs are allowed.

Food may be awarded to the dog in the ring. Praise is a must! Dropping food/luring with food will incur a fault.

Points awarded accumulate towards titles (300 required for titles – 100 points available for each qualifying run).

Prong, choke, pinch or electronic collars are not allowed.

No use of electronics in the ring.

Dogs exhibiting aggression will be asked to leave.


AWARDS

REFUNDS
