Exhibitor Information:

Arrival at the site: 8:00 am. Check in between 8am and 8:30 am.

Limited indoor crating is available. Preference will be given to all day volunteers who are able to arrive at the time we indicate to them when the volunteer schedule is sent out. Other exhibitors may use whatever space is remaining, or work from your vehicles.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs, will be run at the end of their class/trial, and must wear "panties" while competing. Entry fees for bitches that come into season will be refunded until the time of the trial if you wish to withdraw. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

Ribbons will be awarded to all qualifying teams – Rosettes will be awarded for all placements and new titles.
