Exhibitor Information

- Exhibitors are responsible for complete, accurate, and legible information on their entry forms; illegible or incomplete entries cannot be entered in the trial. Entries are complete only after the entry form(s), waiver and fees have been received. A confirmation email will be sent to each competitor once their entry is completed within 48 hours.
- All entries (except for day of entries) must be sent by email to the trial secretary and fees paid by e-transfer.
- Entries received prior to the opening date and time will not be accepted. On site day of trial entries will be accepted.
- Children over 5 are eligible to handle a dog if they can control the animal before, during, and after the hunt. The parent or guardian must always remain on the premises with any child under the age of 16.
- Spectators accompanying owners/handlers can attend the event, but space is very limited for spectator viewing (see waiver form)
- Go Pros or other similar devices may be worn please note restrictions on page 7 of the rule book.
- Competitors may enter a maximum of 6 runs per day per dog which can be any combination of regular classes or games. For example: A dog can be entered each day in 2 regular classes, 2 Dump Hunter classes and 2 Rats in the House classes. Handlers may not enter the same dog twice in the same class on the same day. The maximum number of dogs that can be entered per handler is 4.
- Safety of participants and dogs is of primary concern. By entering these trials, competitors commit to following all instructions/direction from the judge(s) and trial officials.

Site Description

- The four trials will be held at Jazz's Grooming and Training Centre in West Kelowna and indoors on a black matt surface.
- **Directions: From the North:** Drive into West Kelowna on Highway 97 and turn right onto Elk Road. At the first stop sign, turn right onto Louie Drive. Then turn right by the green Nor Val Rental sign and drive down the hill to Jazz's (#2109). **From the South/West:** Drive into West Kelowna on Highway 97 and turn left onto Elk Road. At the first stop sign, turn right onto Louie Drive. Then turn right by the green Nor Val Rental sign and drive down the hill to Jazz's (#2109).
- There are limited electrical and water facilities. Bring your own food and water for you and your dog(s) and any cooling/heating materials needed.
- There is NO camping on site. Parking will be in front or behind Jazz's. There is no crating indoors.

- Designated exercise and potty areas for the dogs will be identified for you. Dogs must be on leash at all times unless running. Please keep 10 feet between dogs.
- There is a toilet and hand washing on site. The site has limited wheelchair accessibility.
- NO smoking or Vaping is permitted anywhere in or by the building.

Dogs

- Dogs must be 6 months of age or older to enter. There is no upper age limit for competing dogs.
- Dogs must always be on lead (maximum 6') except when on course and under control. Note that dogs can become highly excited. Be proactive in managing your dog(s) and respect the needs of others.
- Prong, choke, pinch or electronic collars are not allowed in the staging area or on the way from the staging area to the ring. Dogs may wear belly bands for medical reasons.
- Dogs must run naked in the ring.
- Dogs showing signs of aggression toward people, or other dogs will not be allowed. Aggression is not tolerated which can include actual contact, multiple lunging or excessive barking/growling at dogs and/or people. Unsportsmanlike conduct will not be tolerated.
- Bitches in season may compete but must wear panties in the ring and on the ground except for when pottying. Bitches in season will be staged separately. Advise the Trial Secretary as early as possible if you will be bringing a bitch in season.
- Competitors with multiple dogs in the same class will run in different staging groups and resets will be done for those dogs except for Games. Only one handler per dog is allowed.
- Dogs in wheelchairs, 3 legged dogs, deaf and vision impaired dogs may participate. Shirts may be worn
 for extenuating reasons. Sick dogs, dogs with recent stitches or other conditions are inappropriate for
 competing are not permitted.

Staging

- The ring is inside Jazz's Grooming and Training Centre. There will be limited spectator viewing. Dogs and handlers will wait for their turns in the designated area outside of Jazz's (by the back door). Please be careful when exiting after your turn that you do not run into the other team waiting to go in.
- The gate steward will let you know when you can enter for your turn.
- The judge or gate steward will not wait for any dog holding up a class because the exhibitor is not ready for their runs unless there are extenuating circumstances (see page 14 of the rule book) The Club has no obligation or responsibility for calling or locating dogs that are not brought to the ring when required.

Awards

- Ribbons: Class and game qualifying, 1st 4th place ribbons and title rosettes will be awarded.
 Volunteering
 - Our trials cannot run without volunteers. Volunteer sign-up sheets will be provided, and as needed volunteering positions may be assigned to you at the trial.

Refunds

- No entry fees will be refunded if the trials cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- No refunds after the closing date June 18, 2025 except for sick or injured dogs. You must submit your refund request no later than the day of trial. Refunds will not be issued for dogs who are absent, disqualified, excused, or otherwise barred from participating by the judge or the trial secretary.
- Please stay home if you are sick and a full refund will be given (see also waiver form)

Happy Ratter Rules

• Happy Ratter rules apply at these trials and on the grounds, designated parking areas and the immediate

area. <u>www.happyratters.com</u> By entering these trials, exhibitors acknowledge that they have read and understand these rules.

- Treating/rewarding is allowed per HR rules. Dropped food will incur ten faults.
- There are no age or height divisions in Happy Ratters.
- Trial-to-trial move-ups will be permitted.
- Dogs that have earned their Barn Hunt Novice title(s) or higher, may enter at the Happy Ratter level. Dogs that have earned their Barn Hunt Open title(s) or higher, may enter at the Expert Ratter level. All dogs new to any Happy Ratter Games must enter at level 1.
- Handlers whose dogs have earned a Happy Ratter regular class title can choose to move up to the next
 level or remain in that class at the metallic level. Please identify if you are entering in a regular class or
 metallic on the entry form. An EXCEPTION is made for the Extraordinaire title REX. Dogs that have
 earned their REX, must either move to the Extreme class or back to a lower class.
- NEW Rats will NOT be moved in the Games class even if the handler is running multiple dogs in that game class. Handlers running multiple dogs will know where the rat location is for their subsequent dog(s). An exception is made for level 5 Games and the Infestation games (see page 21)
